February 28, 2019, Introduced by Senator LASATA and referred to the Committee on Appropriations.

A bill to amend 1979 PA 94, entitled
"The state school aid act of 1979,"
by amending sections 236 and 236a (MCL 388.1836 and 388.1836a),
sections 236 and 236a as amended by 2018 PA 265.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

5 Sec. 236a. It is the intent of the legislature to provide
6 appropriations for the fiscal year ending on September 30, ~~2020~~
7 ~~2021~~ for the items listed in section 236. The fiscal year ~~2019-2020~~
8 ~~2020-2021~~ appropriations are anticipated to be the same as those
9 for fiscal year ~~2018-2019,~~ ~~2019-2020~~, except that the amounts will
10 be adjusted for changes in caseload and related costs, federal fund
11 match rates, economic factors, and available revenue. These
12 adjustments will be determined after the January ~~2019-2020~~
13 consensus revenue estimating conference.
