The House Standing Committee on Tax Policy was called to order by the Chair.

Representative O'Malley moved to adopt the meeting minutes from September 11, 2019. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4125 before the committee:

HB 4125 (Rep. VanSingel) A bill to amend 1967 PA 281, entitled "Income tax act of 1967," by amending sections 51 and 51d (MCL 206.51 and 206.51d), as amended by 2018 PA 588; and to repeal acts and parts of acts.

Substitute (H-1) to HB 4125 was previously adopted on September 11, 2019.

Representative O'Malley moved to adopt substitute (H-2) to HB 4125. The motion prevailed 12-2-0:
