- HB 5040 (Rep. Jones) A bill to amend 1990 PA 187, entitled "The pupil transportation act," by amending section 33 (MCL 257.1833), as amended by 2018 PA 422.
- HB 5041 (Rep. Carter) A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 682 (MCL 257.682), as amended by 2012 PA 263.
- HB 5042 (Rep. VanWoerkom) A bill to amend 1990 PA 187, entitled "The pupil transportation act,"(MCL 257.1801 to 257.1877) by adding section 20.
